CALL FOR SUBMISSION OF PROPOSALS FROM NON-PROFIT ORGANISATIONS (NPOs) TO DELIVER SOCIAL DEVELOPMENT SERVICES (YOUTH EMPOWERMENT CENTRES) IN NKANGALA DISTRICT UNDER MPUMALANGA PROVINCE

The Mpumalanga Department of Social Development hereby calls for submission of proposals from suitably qualified NPOs to deliver Social Development Programmes (Youth Development Centres) in the Nkangala District (Mpumalanga) from 2025/26 to 2026/27.

Interested voluntary associations, Non-Profit companies or trusts must also be registered as Non-Profit Organisations (NPOs) in terms of the Non Profit Organisations Act (Act No. 71 of 1997), and be compliant with other relevant legislations (see service specification document).

The application package (comprising of the Business Plan Form and the Service Specifications) may be obtained from any Department of Social Development office or the DSD website.

All Business Plans with the mandatory / compulsory attachments must be hand delivered to a Community Development Practitioner (CDP) at the nearest Social Development offices by **13 October 2025**.

It is the responsibility of the NPO to ensure that its business plan is registered, and the NPO representative signs the submission register.

All NPOs will be subjected to a three-stage assessment process:

- ✓ Stage 1: Evaluation of mandatory documents and NPO registration status.
- ✓ Stage 2: Evaluation of the business plan by the District Assessment Panel.
- ✓ Stage 3: On-Site Assessment.
